This contract is made and entered by and between All Seasons RVA Driving School LLC (located @ 3132 Kim dr. N. Chesterfield, VA 23224)

(Parent or legal guardian) If the Student is under the age of 18, a state approved driver education program consists of thirty-six (36) 50-minute periods of classroom and fourteen (14) 50-minute periods of in car instruction (seven 50-minute periods of driving and seven 50-minute periods of observation). In vehicle, should not exceed two periods within 24 hours (one period of driving and one period of observation). All seasons RVA Driving School agrees to provide the state approved Behind the wheel program only, for the cost of \$260. There may be an additional charge of \$25 for pick up. This fee is payable by cash, personal check, money order or credit card. (Visa, MasterCard, Discover, American Express)

All Seasons RVA Driving School and the Student agree to the following terms and conditions:

- Behind the wheel instruction is conducted by appointment only and the student may be charged regular school rate of \$40.00 for any appointment he/she does not meet, unless the school is given at least 24 hours' notice
- There will be a \$35 service charge on all returned checks
- A refund of any fees or tuition will be provided, upon written request, unless the school is capable or willing to perform its part of the contract within a reasonable time.
- No Certification will be issued until all fees have been paid in full.
- The school will complete the course in a reasonable length of time; however, it cannot be held responsible for delays caused by mechanical failure, unsafe driving conditions due to bad weather or any reason which it has no control. The school will give the student as much notice as possible of any delays.
- The instruction period does not guarantee that any student will pass the state license examination or secure a license, nor does the completed instruction guarantee employment of any kind.
- Missed In-vehicle instruction may be completed in a timely fashion at the discretion of the school director and as permitted by the availability of scheduled instructors.
- Each school vehicle is fully insured
- The fees set herein are guaranteed for 90 days from the date of this executed contract.
- If additional instruction or service is provided after conclusion of the course described herein, the fee will be \$40 per lesson for behind the wheel instruction.
- Students requesting use of a school vehicle for the DMV road examination will be charged \$80 for each attempt.

Normal instruction for All Seasons RVA Driving School is to have 2 to 3 students in the automobile during instruction. If an occasion should arise, where this is not possible, my permission is given for _____ . (student) to work with an instructor on a one on one basis.
