This contract is made and entered by and between All Seasons RVA Driving School (located @ 302 Turner Rd, Suite L, N. Chesterfield, VA 23225) and \_\_\_\_\_ . The student will receive a state approved driver education program that consists of thirty-six (36) 50-minute periods of classroom and fourteen (14) 50-minute periods of in car instruction (seven 50-minute periods of driving and seven 50-minute periods of observation). All seasons RVA Driving School agrees to provide the state approved 30-hour classroom course for the cost of \$130 and behind the wheel program, for the cost of \$370. There may be an additional charge of \$25 for pick up. The fee is payable by cash, personal check, money order or credit card. (Visa, MasterCard, Discover, American Express)

### All Seasons RVA Driving School and the Student agree to the following terms and conditions:

- Behind the wheel instruction is conducted by appointment only and the student may be charged regular school rate of \$52.00 for any appointment he/she does not meet, unless the school is given at least 24 hours' notice
- There will be a \$35 service charge on all returned checks
- A refund of any fees or tuition will be provided, upon written request, unless the school is capable or willing to perform its part of the contract within a reasonable time.
- No certification will be issued until all fees have been paid in full.
- The school will complete the course in a reasonable length of time; however, it cannot be held responsible for delays caused by mechanical failure, unsafe driving conditions due to bad weather or any reason which it has no control. The school will give the student as much notice as possible of any delays.
- The instruction period does not guarantee that any student will pass the state license examination or secure a license, nor does the completed instruction guarantee employment of any kind.
- Missed In-vehicle instruction may be completed in a timely fashion at the discretion of the school director and as permitted by the availability of scheduled instructors.
- Each school vehicle is fully insured
- The fees set herein are guaranteed for 90 days from the date of this executed contract.
- If additional instruction or service is provided after conclusion of the course described herein, the fee will be \$60 per lesson for behind the wheel instruction.
